## Entry Requirements & Information

- ◆ You **MUST** be 21 to enter \* Can be a team of 3 maximum
- ◆ Set-up will begin at 2pm \* **START** is at 4:00pm \* **JUDGING** at 5pm
- ◆ Three glasses of the exact same cocktail must be made for the Judging -
- ◆ Any type of alcohol is acceptable \***BONUS POINTS** for using products distilled in Central Oregon - Please indicate on recipe form
- ◆ Entrants will set-up their “bar” on a 2x4 table provided starting at 2pm - Making of drinks begin at 4pm, ready for judges at 5pm
- ◆ Entries will be judged on :
  - 1) Taste / Balance - Flavor balance (sweet sour, bitter, alcohol) Smoothness and drinkability
  - 2) Creativity / Originality - Unique concept or ingredients - Memorable name
  - 3) Presentation / Appearance - Visual appeal (color, garnish, glassware) - “Wow factor”
  - 4) Theme Alignment (Frontier Days / 50th Anniversary) -does it reflect La Pine, hometown spirit, or Americana? Creative tie to the 50th Anniversary Celebration
  - 5) Aroma - inviting scent - enhances drinking experience
  - 6) Practicality/ replicability - Could this realistically be served at events/bars? Ingredient accessibility
